PUBLIC HEARING

General Plan Amendment Revisions to the Traffic Circulation Pan-Map 8

Mr. Pregler gave the staff presentation. A power point presentation was provided to complement the discussion. Mr. Pregler stated that the revisions to the Traffic Circulation Plan include changing the street classifications to be more consistent with state and federal roadway functional classifications. The existing Collector and Residential Connector roadways are proposed to be reclassified as Major Connector and Minor Collector roadways. Staff identified four existing roadways that were to be reclassified on the Traffic Circulation Plan as Minor Collectors: Foothills Drive, El Camino Real, Wilcox (east of the Cochise College campus), and Golf Links Road.

Mr. Malone asked how the above stated roadways were different than Greenbriar Drive? Mr. Pregler stated that there is similar design and functionality between Greenbriar and the proposed reclassified roadways. However, Greenbriar does not have a designation of Major Collector, so no revision is needed.

#### Discussion Item

General Plan Update-Land Use Element. Staff continued with the PowerPoint presentation that began back in November. Under the Land Use Element, staff discussed the following goals:

- Goal 2-2, Coordinate with Ft. Huachuca for all future City development;
- Goal 2-3, Economic development shall be considered when planning future sites;
- Goal 2-4, Consider environmental impacts when planning future sites;
- Goal 2-5, Develop and implement aesthetic standards along all major roadways and gateways into the City;
- Goal 2-6, Plan appropriate development of vacant State Trust Land located within the City;
- Goal 2-7, Annex areas that provide the most benefit to the City as stated in the City's Annexation Policy.

The following goals were discussed under the Growth Element:

- Goal 5-1, Ensure Growth Areas are developed meeting community expectations;
- Goal 5-2, Coordinate with other government agencies when developing in the growth areas;
- Goal 5-3, Create strategies that ensure economic diversity within growth areas.

The following goals were discussed under the Urban Design Element:

Goal 17-1, Make Sierra Vista a City distinguished by its orderly and aesthetic character;

Goal 17-2, Develop a cohesive urban character that makes Sierra Vista a community unto itself;

Goal 17-3, Provide a variety of housing types;

Goal 17-4, Develop a Town Center.

There was general discussion to follow with the continued comment that the City needs a sense of identity. Various functions, events, and aesthetic features were suggested.
