#### ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

#### CAMP SPARK FACT SHFFT

Thank you for your interest in Sierra Vista Fire and Medical Services "CAMP SPARK" program, a fire service empowerment camp for girls. CAMP SPARK is a one-day event taking place on July 27th at Fire Station #3, 675 Giulio Cesare Ave, Sierra Vista AZ. Please review the helpful information below before submitting your Camp SPARK application.

#### Attire and Equipment

 Campers must wear loose fitting exercise clothes, their CAMP SPARK t-shirt and dark colored shorts with athletic shoes. Camp Spark shirts will be for pickup at Station 203 and should be worn during the entire time of the camp. We recommend having an additional change of clothes in a small bag and a towel.
 Hair must be properly secured/tied up to fit into a helmet when needed. Food and beverages will be provided.

#### • Hours of Operation

Campers should be at the camp by 7:45 a.m. Camp activities will end at 6:00 p.m. All campers are required to participate in clean-up activities at the end of the day. Clean-up may take at least 30 minutes. Campers are expected to attend the entire time of the activities. Plan to be there at 6:00pm for camper pick-up and closing ceremonies from 6:00-7:00 p.m.

#### • Transportation to and from CAMP SPARK

Campers are responsible for their own transportation to and from the camp.
 Parents/guardians/friends/family members are not permitted to remain at the camp site during the daily activities. There will be designated drop-off and pick-up areas once you arrive at the camp.

#### Personal Items

 We encourage campers not to bring unnecessary valuable items to the camp site. You may bring your cell phone but will not be permitted to use them during camp activities. You will be responsible for any loss or damages to your personal items. A towel and a change of clothes are recommended and should be in a small bag that can be kept on site.

#### • Safety, Rules and Regulations

Safety is a top priority at CAMP SPARK. All campers will be expected to follow the rules and instructions provided by the camp instructors, counselors, mentors and safety personnel. Any camper that does not follow rules or instructions or who does not display a positive attitude will not be permitted to participate in camp activities and will be required to notify their parent or guardian to pick them up immediately.

#### Participation in Camp Activities

Campers are expected to participate in each activity to the extent they are able. It is expected campers
will participate in the physical training (squats, push-ups, stretching, etc.) to prepare them for the day's
activities.

#### Graduation Ceremony

At the end of the day, a brief graduation ceremony will be held at 1800 (6:00 p.m.) to acknowledge the
achievements of each camper. Parents, guardians, friends and family members are all invited to attend
at 6:00 p.m. for the closing ceremony, lasting until 7:00 p.m.

#### CAMP SPARK INFORMATION SHEET

Sierra Vista Fire and Medical Services is excited to host it's first ever, CAMP SPARK. This exciting one-day camp is designed to introduce young girls ages 12-18 to the fire service industry and provide insight into what's required to become a Firefighter, Paramedic or EMT. Our hope is to inspire participants to consider the fire department as a viable career option.

CAMP SPARK is unique in the sense that it provides an opportunity for young girls to learn leadership skills, team building, critical thinking, as well as situational awareness in addition to principles of fireground operations. Participants will also engage in real world firefighting scenarios, hands-on fire and EMS simulations in addition to hands-only CPR, stop the bleed and fire prevention education. Not only will students learn the basics of fire safety, but they will also learn about their role in society, the importance of smoke alarms installations and practicing fire escape plans.

Participants will engage in a variety of hands-on practical training to include donning/doffing turnout gear, handle a charged hose line, explore a maze and hose hoist in addition to a bucket brigade and firefighter relay.
