Mr. Johnson commented that it's been a while and has noticed a lot of new hires in the Police Department. Mr. Yarbrough explained that she has been signing off on the new hires as Acting Secretary but commented on the urgency of the next meeting needed but wanted to get the admin meeting out of the way. Mr. Johnson asked for clarification on statutory requirement to meet and

Mr. Smith confirmed it was two a year. Mr. Andela commented that they are not split up like a non-specific number of months in between. Mr. Smith commented the last meeting was in November 2023 with further discussion that the administrative meeting was good timing.

Ms. Ferrel asked if there were any updates on the Jock Russell case as she heard it was moving up. Mr. Johnson mentioned he has heard nothing regarding the case. Ms. Ferrel and Mr. Johnson both confirmed there has been no notification from lawyers or anything.

Mr. Johnson mentioned he has an inquiry of "Denels boy" who was present with his family but it was a Fire Fighter case. Mr. Smith confirmed it was Fire. Mr. Johnson was concerned as he has made a number of recommendations to him that needed to be fulfilled before they can consider an independent medical examiner.

Mr. Andela said he hadn't heard anything regarding the case and asked for clarification if it was being reversed. Ms. Ferrel said decision was overturned and Mr. Andela asked if it was giving the pension was overturned and Ms. Ferrel clarified the decision was the original decision and that it was in the court of appeals and some concern about action taken against the board.
