RESOLUTION 2024-061

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; ACCEPTING THE RESIGNATION OF RYLEY ABSALON, WITH REGRET, FROM THE YOUTH COMMISSION; AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the Mayor and City Council have re-established a Youth Commission to advise on matters of concern to the youth of Sierra Vista, and to recommend and encourage action programs and legislation beneficial to the youth of the community; promote better understanding and integration of youth and the local government, and assist in the planning, operation, and evaluation of the local service delivery system for youth related services as consumers of these services;

WHEREAS, Ryley Absalon has termed out and left the area to attend college;

WHEREAS, it is settled policy of the City Council that resignations from boards and commissions be approved, with regret.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the Council policy of accepting resignations from boards and commissions, with regret, be and is hereby reaffirmed.

SECTION 2

The City Council hereby accepts the resignation of Ryley Absalon from the Sierra Vista Youth Commission.

SECTION 3

The City Manager, City Clerk, and City Attorney, or their duly authorized officers and agents, are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this resolution.
