BACKGROUND:

The City has retained the services of an attorney for general water rights advice related to various federal, state, and water issues for over 30 years, including representation as counsel of record specifically for these contested matters:

In re Subflow Technical Report, San Pedro River Watershed ("Subflow Matter")
Maricopa County Superior Court Case No. W1-103

In re General Adjudication ... Gila River System and Source ("Gila River Adjudication")

Maricopa County Superior Court Case No. W-1, W-2, W-3, and W-4 (Consolidated)

In re San Pedro Riparian National Conservation Area ("SPRNCA Matter")
Maricopa County Superior Court Case No. W-1-11-232

Chapter 31.07 of the City Code states Counsel of the City is appointed by the Mayor and City Council. Mr. Haws has been an attorney in Arizona for 35 years, specializing in water law, and most recently retired from Fort Huachuca as its Water and Environmental Law attorney after 32 years. He is exceptionally well qualified to advise the City on all water-related matters and conveniently lives locally.

BUDGET APPROPRIATIONS:

The City budgets \$20,000 per year for water representation. Mr. Haws's rate is \$300/hr.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; APPOINTING DANIEL D. HAWS II AS COUNSEL FOR WATER REPRESENTATION SAID TERM TO EXPIRE OCTOBER 9, 2029; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION AND DECLARING AN EMERGENCY

WHEREAS, Chapter 31.07 of the Code of the City of Sierra Vista requires the appointment of all Counsel; and

WHEREAS, the City requires representation by an attorney specializing in water-related matters in multiple water-related cases and for general water rights advice; and

WHEREAS, Daniel D. Haws II responded to a publicly-posted Request for Qualifications and is exceptionally qualified based on his 32 years of experience and knowledge specifically related to federal, state, and local water law issues; and

WHEREAS, the term of the agreement shall be for one (1) year from the date of execution with an annual extension option up to four (4) additional years, not to exceed five (5) total years;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the City Council appoints Daniel D. Haws II as Counsel for water representation and general water rights advice, said term to expire October 9, 2029.

SECTION 2

The City Manager, City Clerk, City Attorney, or their duly authorized officers and agents are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this Resolution.
