BACKGROUND:

Thie resolution seeks approval from the Mayor and Council to acknowledge the dedicated service of Retired Sierra Vista Police Department Canine Bones by dedicating the Dog Park located at Hubert Tompkins Park in his memory. Canine Bones served the Sierra Vista Police Department from 2012 to 2021 and exemplified loyalty, courage, and unwavering commitment to his community. Upon his retirement at age 12, Canine Bones lived out his remaining years with his trusted partner, Sgt. Justin Allyn, until his recent passing.

During his distinguished career, Canine Bones worked alongside Sgt. Allyn from 2016 to 2021, deploying his exceptional skills 679 times in narcotic detection and patrol apprehension. Their partnership led to the discovery of 354 drug paraphernalia items, the seizure of 473 pounds of marijuana, over 850 grams of illegal narcotics, and 206 arrests. His contributions greatly enhanced public safety and community well-being.

As we remember Canine Bones, we celebrate his legacy of service. Naming the Dog Park in his honor will provide a lasting tribute to his loyalty and the important role he played in protecting our city.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA AS FOLLOWS:

The policy of dedicating City facilities and/or areas after citizens who have worked selflessly contributing to our community, be, and hereby is, reaffirmed.

SECTION 2

The Mayor and City Council, honoring the contributions of Canine Bones, hereby dedicate the Dog Park located at Hubert Tompkins Park in his honor.
