#### Background:

This Resolution directs the City Manager and staff to take the necessary actions to complete the purchase of the described property for a total amount of \$230,000.03, which includes a 3% Broker's fee.

This property is in an area which supports the Mayor and Council's West End redevelopment efforts. The property also has the potential to assist with storm water mitigation and to provide an additional community event venue in the future.
