#### Sierra Vista City Council Meeting Minutes October 8, 2020

Mayor Mueller called the October 8, 2020 City Council Meeting to order at 5:00 p.m., Council Chambers, City Hall, 1011 N. Coronado Drive, Sierra Vista, AZ

Invocation – Pastor Becky Preiss, Hope and Healing Christian Church, conducted the invocation.

Pledge of Allegiance: Council Member Benning led the Pledge of Allegiance.

#### Item 1 Acceptance of the Agenda

Council Member Umphrey moved that the Agenda for the Regular City Council Meeting of October 8, 2020 be approved as written. Council Member Wolfe seconded the motion. The motion passed by a 5/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

#### Awards and Presentations

A presentation of the Sierra VistAbility Award was made by the Commission on Disability Issues to Sierra Toyota for providing an application for customers to schedule appointments, which has been helpful for individuals with a speech impediment or social anxiety.

Mr. Pregler explained that the Sierra VistAbility Award recognizes businesses and individuals that go above and beyond the Federal and State Law requirements for accessibility and accommodations for individuals with disabilities. Sierra Toyota is being recognized because they provided an application for customers that allows them to schedule appointments. Ms. Charles, Commissioner for the Commission on Disability Issues, stated that she nominated Sierra Toyota because as a person who stutters with a speech impediment, the quick ride app created by Sierra Toyota made it easier for her.

Mr. Han thanked everyone and noted that Sierra Toyota's principle is, "4 everyone," and the first one is to welcome everyone, number two is to respect everyone, number three is to honor everyone and number four is to serve everyone.

The Mayor read and presented a proclamation declaring October as Fire Prevention Month to Fire Chief Jones. Fire Chief Jones thanked Mayor Mueller and Council and stated that the message this year is "serving up fire safety in the kitchen." He noted that although the Fire Department is not going to be able to get out to the schools, the Department has been in contact with the School District and will be sending out virtual messages.

City Manager's Report: Mr. Potucek announced that the next regularly scheduled City Council Work Session will be held on October 20, 2020 at 3:00 p.m. in Council Chambers and the next regularly scheduled Council Meeting will be held on October 22, 2020 at 5:00 p.m. also in Council Chambers. He reported that the Coronado Drive pavement replacement project, annual maintenance, bids were received on September 8, 2020 and was awarded to KE&G in the amount of \$711,453.10 (the curb from Mormon to Fry Boulevard). The WHIP Portal Project for the Upper San Pedro Partnership's public engagement portion was awarded to the Gordley Group in the amount of \$33,000, and the City Hall west wing remodeling project is progressing and should be finished by the end of the month. He also reported on the SEACOM JPA Board Meeting, where they discussed the emergency medical dispatch kickoff (hoping for a demonstration on October 20, 2020), and the County's application and receipt of a grant for the Motorola software upgrade in the amount of about \$160,000. He noted that the project was about a \$750,000 hit to the SEACOM budget, but the City and the County will both benefit positively in the budget this year.

Council Member Pacheco moved that the Consent Agenda consisting of the City Council Regular Meeting Minutes of September 10, 2020 and September 22, 2020, Resolution 2020-058, re-appointing Barbara Fleming and Gary Smith to the Sierra Vista Police and Fire Pension Boards, said terms to expire August 1, 2024, Resolution 2020-059, release of Improvement Security for Retreat Phase 2, Lots 64-69, 91-141, be approved. Council Member Umphrey seconded the motion. The motion passed by a 5/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

**New Business** 

<u>Item 3</u> Resolution 2020-060, Approval of 2020 Title VI Nondiscrimination Plan for the City of Sierra Vista / Vista Transit

Council Member Wolfe moved that Resolution 2020-060, 2020 Title VI Nondiscrimination Plan for the City of Sierra Vista / Vista Transit, be approved. Council Member Benning seconded the motion.

Ms. Adams stated that the item is a triannual update of the Vista Transit Title VI Nondiscrimination Plan. The Plan is not different than the previous Plan submitted in October 2017. The update reflects the status of Vista Transit to correct names and contact information, with some information streamlined out. Due to the pandemic the Transportation Advisory Committee has not met; however, when they do get up and running, staff will provide an update of the Plan through the Transit System.

Plans are required by all transit agencies that receive federal grants for the operations or purchases of busses by the Federal Transit Administration and the Federal Department of Transportation. The City has benefited greatly over the years and continues to look forward to that relationship with the federal government. The City will submit this Plan, although the City has always abided by the federal laws. This is a document that provides a framework of how the City is going to do it to the utmost ability for the transit system, which does tend to serve a lot of the people who are in the protected classes.

Ms. Adams noted that at the work session, Council Member Pacheco asked about sexual orientation and gender identity, and after conferring with the City Attorney, and doing some research, it was found that sexual orientation and gender identity is not covered under Title VI. The other added federal regulations generally cover gender identity and sexual orientation under the term sex as a protected class. Therefore, the Plan does cover all those classes. If approved, the Plan will be uploaded to the federal website.

Council Member Pacheco stated that there is a law that passed through the House to put that in a separate class. Ms. Adams stated that it is called the Equality Act and it was passed by the congressional body in May 2019 and forwarded to the Senate, but it is still with the Senate and has not died. Until it goes through both bodies and up to the President, it does not become law. Case law and other equally enforceable rules for the most part have added those two groups under the term sex, specifically for employment practices.

The motion passed by a 6/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

<u>Item 4</u> Resolution 2020-061, Authorization to Accept Arizona Governor's Office of Highway Safety Grant Funding (Contract #2021-PTS-063)

Council Member Umphrey moved that Resolution 2020-061, authorization to accept Arizona Governor's Office of Highway Safety Grant Funding (Contract #2021-PTS-063), be approved. Council Member Pacheco seconded the motion. The motion passed by a 5/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

Police Chief Adams stated that the resolution is to accept the grant from the Governor's Office of Highway Safety in the amount of \$5,220 to purchase two LIDAR speed detection devices. This is part of the Governor's Office selected traffic enforcement program to combat aggressive driving. The unit is to detect speed when it is a primary offense regarding the aggressive driving statute in Arizona. The two units will be used as part of the deployments and on regular patrol for those officers that are certified to use them.

The motion passed by a 5/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

<u>Item 5</u> Resolution 2020-062, Authorization to Accept Arizona Governor's Office of Highway Safety Grant Funding (Contract #2021-AL-031)

Council Member Pacheco moved that Resolution 2020-062, authorization to accept Arizona Governor's Office of Highway Safety Grant Funding (Contract #2021-AL-031), be approved. Council Member Umphrey seconded the motion.

Police Chief Adams stated that this resolution accepts the grant from the Governor's Office of Highway Safety in the amount of \$31,829 to pay for overtime and employee related expenses regarding the separate DUI deployments that the City's Police Department does as part of the DUI Task Force. This grant also will reimburse the City for four portable drug testers that are used as part of a sobriety testing in the amount of \$1,829. These deployments are throughout the County as part of the Task Force. One was recently held in Wilcox, Arizona for the Rex Allen Days, but most of those deployments are in the Sierra Vista area.

In response to Council Member Pacheco, Police Chief Adams stated that the Police Department provides reports to the Governor's Office, which he can make available to Council. He added that one of the major goals of the Department, as part of the deployments, is to reduce DUI-related fatalities/crashes. He noted that the number of cases was over a 20 percent reduction last year. There were over 200 DUI arrests and that was not just through the deployments.

The motion passed by a 5/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

<u>Item 6</u> Resolution 2020-063, Authorization to Accept Phoenix Police Department (Primary Grantee)/Arizona Internet Crimes Against Children (ICAC) Lead Agency Grant Funding

Council Member Benning moved that Resolution 2020-063, authorization to accept Phoenix Police Department (Primary Grantee)/Arizona Internet Crimes Against Children Lead Agency Grant Funding, be approved. Council Member Umphrey seconded the motion.

Police Chief Adams stated that this resolution accepts the grant and an intergovernmental agreement to become a part of the Arizona Internet Crimes Against Children Task Force with the Phoenix Police Department, the primary grantee. These funds are supplied by the Department of Justice, Office of Juvenile Justice and Delinquency Prevention Program and Task Force. The primary task is to investigate images taken for sexual exploitation of minors, and to combat the luring of minors for sexual offenses. The funds in the amount of \$5,000 will be used primarily for training new officers as part of the Task Force that help with the investigations and to probably buy some software upgrades for some of the computers that will be used.

Council Member Pacheco asked if this is the first year that the City has received this grant and how the program works. Police Chief Adams stated that this is the first year that the City has received the grant. There will be more operations available with local agencies including Fort Huachuca and Homeland Security working to identify and catch predators that are using the internet to lure children. The Phoenix Police Department is the primary grantee, and the Sierra Vista Police Department will work with all the other agencies that are also a part of the ICAC. The Phoenix Police Department operates the grant, get all the funding from Department of

Justice, and then distribute it to those that are members of the Task Force for training or equipment.

The motion passed by a 5/0 vote of Mayor Mueller, Council Members Benning, Umphrey, Wolfe, and Pacheco.

Call to the Public

Daniel Webster reported on a series of events that he witnessed at Veterans' Memorial Park and requested that police officers patrol the park on foot. He also talked about his disappointment of the County Attorney's decision on the McEntire case.

Michael De Carlo talked about the reason why there are governments, quoted Mark Twain, commented on the cancellation of the regularly scheduled Council Meeting and the setup of a Special Meeting to purchase property for \$200,000, and the Fort Huachuca Joint Research Utilization Study, a rename of the land use studies. Lastly, he commented on SEACOM and congratulated Police Chief Adams on securing \$42,000 in grants.

Comments and Requests of the Council

Council Member Benning congratulated Sierra Toyota, Fire Chief Jones and the Fire Department and Police Chief Adams for acquiring the grants. He thanked Mr. Webster and Mr. De Carlo for attending the meeting and addressing the Council. He also thanked Pastor Becky and quoted Mark Twain, "kindness is a language which the deaf can hear and the blind can see."

Council Member Umphrey wished her favorite Arizona Ranger, her father, a Happy Birthday.

Council Member Pacheco had nothing to report.

Council Member Wolfe announced the voter registration extension in the State of Arizona and encouraged people to register. She also shared her experience with smoke detectors and noted that the Fire Department will help with changing out the batteries.

Mayor Mueller announced that flu shots are now available, and encouraged people to get their shots, especially the elderly. He noted that the census has been extended to the end of October and announced that voting has started in Arizona. He encouraged people to register and go out and vote. Lastly, he reported that Monday, October 12, 2020 is a holiday, but a workday for the City because the employees will get the Friday after Thanksgiving off instead.

Mayor Mueller adjourned the October 8, 2020 meeting of the Sierra Vista City Council at 5:40 p.m.

Request for a Substitution of Documents for Holiday at

Pueblo Del Sol, Phase 5A Final Plat, Lots 1-29

#### **RECOMMENDATION:**

The City Manager recommends approval.

The Director of Community Development recommends approval.

#### BACKGROUND:

The final subdivision plat for Holiday at Pueblo Del Sol, Phase 5A, Lots 1-29, was approved by the City Council on June 25, 2020. At the time the plat was approved, the City Council accepted a Subdivider's Agreement and an Improvement Security (Improvement Bond) as an assurance for completion of the public improvements. The Surety for the improvement bond was Lexon Surety Group.

Castle & Cooke Arizona, Inc., the developer of the property, has decided to change Sureties from Lexon Surety Group to Seneca Insurance Company. As a result, a replacement Improvement Security with the Surety Seneca Insurance Company is required to be approved. Approval of the Resolution would release the current Improvement Security and substitute it with the proposed Security.

The settled policy of the City is to grant such a request if the City Council feels that the substitution is in the best interests of the public.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; REAFFIRMING SETTLED POLICY GRANTING A SUBSTITUTION OF DOCUMENTS TO ASSURE THE COMPLETION OF PUBLIC IMPROVEMENTS ASSOCIATED WITH THE DEVELOPMENT OF HOLIDAY AT PUEBLO DEL SOL, PHASE 5A, LOTS 1-29; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, on June 25, 2020, the Mayor and City Council passed Resolution 2020-036 approving the final subdivision plat for the Holiday at Pueblo Del Sol, Phase 5A, Lots 1-29; and

WHEREAS, certain documents were recorded with the Cochise County Recorder, said documents being an Improvement Security Guaranty Agreement by and between Castle & Cooke Arizona, Inc., and the Lexon Surety Group, under bond number LICX1190534 as recorded under Fee No. 2020-19443, for the completion and security of public improvements associated with the development of Holiday at Pueblo Del Sol, Phase 5A, Lots 1-29; and

WHEREAS, Castle & Cooke Arizona Inc., as developer of the subdivision, desires to substitute documents making Seneca Insurance Company the Surety of the Improvement Security Guaranty Agreement, as identified by Bond number POA1003249; and

WHEREAS, Castle & Cooke Arizona Inc., has requested that the necessary documents be prepared to accomplish the requested substitution; and

WHEREAS, the City of Sierra Vista feels that it is in the best interests of the public to accept a new document as security for the completion of the required public improvements associated with the development of Holiday at Pueblo Del Sol, Phase 5A, Lots 1-29.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

#### RECOMMENDATION

The City Manager recommends approval of the attached Development Fees corresponding to the Land Use Assumptions and Infrastructure Improvement Plan approved by City Council on September 10, 2020.

#### BACKGROUND

Arizona Revised Statute 9-463 specifies the process by which the City Council updates its development (impact) fees. A draft copy of the Land Use Assumptions (LUA) and Infrastructure Improvement Plan (IIP) and Development Fee report was uploaded onto the City's website in early January to advertise the City's intent to begin the process. In the following months, staff continued to work with the City's consultant, TischlerBise, to finalize required documents. On June 11<sup>th</sup>, Council held the required public hearing on the LUA and IIP and subsequently approved the documents on September 11, 2020. On October 22, 2020, Council held the required public hearing on the proposed development fees. On December 10<sup>th</sup>, Council will vote on the corresponding development fees and the new construction tax rate decrease. According to the City's Code of Ordinances, 154.10 - 154.20, the Council may adopt by resolution the updated LUA, IIP and development fees. The final step of the process will be Council's approval of the Ordinance in January, 30 days after the adoption of the fees. If approved, the new fees will go into effect on March 1, 2021.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; APPROVING THE DEVELOPMENT FEE SCHEDULE THAT CORRESPONDS TO THE LAND USE ASSUMPTIONS AND INFRASTRUCTURE IMPROVEMENT PLANS APPROVED BY CITY COUNCIL ON SEPTEMBER 10, 2020 IN ACCORDANCE WITH A.R.S. 9-463, AND CITY CODE 154.10-20; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the City of Sierra Vista assesses development fees to offset costs to the City associated with providing necessary public services to a development, as specified in Chapter 154 of the City Code of Ordinances; and

WHEREAS, Arizona Revised Statue §9-463 and City Code Chapter 154 specifies the procedure by which the City must follow in order to update its fees to reflect current growth patterns and anticipated new construction; and

WHEREAS, in accordance with state law, two public hearings were held on June 11, 2020 regarding the Land Use Assumptions and Infrastructure Improvement Plan, as well as the corresponding Development Fee schedule on October 22, 2020; and

WHEREAS, the Council approved the Land Use Assumptions and Infrastructure Improvement Plan on September 10, 2020 as the first step toward setting the revised development fees; and

WHEREAS, the new development fee schedule offsets infrastructure costs to the City for necessary public services and adoption of the revised development fee schedule is the last step in the process.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

#### SECTION 1

That the settled policy of the City Council, supporting the assessment of Development Fees to offset the costs to the City associated with providing necessary public services to new development be, and hereby is, reaffirmed.

That the City Council hereby approves the revised development fee schedule identified on Attachment A that corresponds to the Land Use Assumptions and Infrastructure Improvement Plan reports previously adopted by the elected body on September 10, 2020, said fees effective March 1, 2021 in accordance with state law.

The City Manager, City Clerk, City Attorney, or their duly authorized officers and agents are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this Resolution.
