

RESOLUTION 2022-012

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA: AUTHORIZING THE CITY TO DONATE EQUIPMENT AND FOUR FORD CROWN VICTORIA SEDAN TO COCHISE COLLEGE AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY, OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the City of Sierra Vista has donated surplus vehicles and equipment in the past to help its neighbors; and

WHEREAS, the City has four surplus Ford Crown Victoria vehicles with red and blue emergency lights with unitrols (for three) to donate to Cochise College; and

WHEREAS, Cochise College and its law enforcement certification academy (SEALETA) can realize tremendous benefit from obtaining these vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

The policy of the City of Sierra Vista relating to the donation of surplus items to our neighbors, when feasible and appropriate to do so, is hereby reaffirmed.


SECTION 2

The Mayor and City Council hereby authorize the donation of four surplus Ford Crown Victoria sedans to Cochise College. The City is donating the vehicles as is, with no guarantees or warranties.

SECTION 3

The City Manager, City Clerk, City Attorney, or their duly authorized officers and agents are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this Resolution.



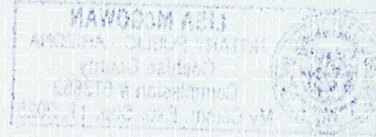

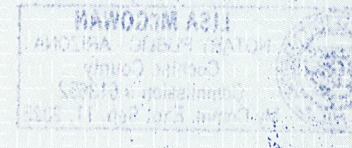
