A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; AFFIRMING ESTABLISHED POLICY; FINDING, DECLARING AND CERTIFYING THE OFFICIAL CANVASS OF THE GENERAL ELECTION HELD ON NOVEMBER 3, 2020; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the City Council met in special session on November 19, 2020 to declare and adopt the results of the November 3, 2020 General Election; and

WHEREAS, there were two official and four qualified write-in candides eligible to be elected. Of the four write-in candidates, two candidates received sufficient votes to qualify for election; and

WHEREAS, the City Council has reviewed the results of the General Election for the three City Council Seats and have found the election was run and processed by the Cochise County Elections Department according to law; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the established policy relating to the canvassing of elections is hereby reaffirmed.

SECTION 2

The City Council of the City of Sierra Vista, Arizona does hereby find, declare, and certify that the election results detailed in Exhibit "A" is the official canvass of the General Election held on November 3, 2020.

Of the six candidates running for the three open seats on the Sierra Vista City Council, Rachel Gray, Angelica Landry and Gregory L. Johnson received the highest number of votes and will take office January 1, 2021.
