RESOLUTION 2023-014

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; CREATING THE TRANSPORTATION COMMISSION, NEIGHBORHOODS COMMISSION, ENVIRONMENTAL STEWARDSHIP COMMISSION, AND THE ARTS, HUMANITIES, & CULTURAL DIVERSITY COMMISSION; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the Sierra Vista City Council and the City of Sierra Vista have, for many years, utilized the knowledge and talents of the citizens of Sierra Vista in many areas through its City Council Advisory Commissions; and

WHEREAS, the Sierra Vista City Council regularly evaluates the structure of its commissions, and last changed commission functions by Resolution 2020-028, dissolving some City Council advisory bodies and reestablishing them as Departmental Commissions; and

WHEREAS, the City Council wishes to continue the tradition of citizen participation in the development of policies and other projects; and

WHEREAS, the City Council believes that the creation of new commissions focusing on Transportation, Neighborhoods, Environmental Stewardship, and Arts, Humanities, & Cultural Diversity would enhance the ability of the commissioners and staff to better utilize that participation;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the Transportation Commission, Neighborhoods Commission, Environmental Stewardship Commission, and Arts, Humanities, & Cultural Diversity Commission, are hereby created.

SECTION 2

That the established policy of the Sierra Vista City Council to utilize the knowledge and talents of the citizens of Sierra Vista in many areas through its City Council Advisory Commissions is hereby reaffirmed.
