

RESOLUTION 2023-015

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; RE-ESTABLISHING THE COMMISSION ON DISABILITY ISSUES, TOURISM COMMISSION, AND YOUTH COMMISSION AS CITY COUNCIL ADVISORY COMMISSIONS; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the Sierra Vista City Council and the City of Sierra Vista have, for many years, utilized the knowledge and talents of the citizens of Sierra Vista in many areas through its City Council Advisory Commissions, and

WHEREAS, the Commission on Disability Issues was last re-established by City Council Resolution 3702 on October 24, 1996; and

WHEREAS, the Tourism Commission was last re-established by City Council Resolution 2008-181 on December 11, 2008; and

WHEREAS, the Youth Commission was last re-established by City Council Resolution 3716 on December 12, 1996; and

WHEREAS, the Sierra Vista City Council regularly evaluates the structure of its commissions, and last changed commission functions by Resolution 2020-028, dissolving some City Council advisory bodies and reestablishing them as Departmental Commissions; and

WHEREAS, the City Council wishes to continue the tradition of citizen participation in the development of policies and other projects; and

WHEREAS, the City Council believes that the creation of several new commissions focusing on Transportation, Neighborhoods, Environmental Stewardship, and Arts, Humanities, & Cultural Diversity would enhance the ability of the commissioners and staff to better utilize that participation; and

WHEREAS, the City Council believes re-establishing the Commission on Disability Issues, Tourism Commission, and the Youth Commission as City Council Advisory Commissions would best serve the community.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the Commission on Disability Issues, Tourism Commission, and the Youth Commission are hereby re-established as City Council Advisory Commissions.


SECTION 2
