BACKGROUND:

On February 24, 2023, the City Council took action to dissolve the West End Commission and establish a new Council advisory Neighborhoods Commission. WHEREAS, applications for the Neighborhood Commission have been received from Julia McCaa, Tait Wilcox, Janet Wilcox, and Rosie Mackey.
