There were three active commissioners in the nonregulatory Youth Commission, Sophia Rosa, Rylee Absalon, and Aubrey Travis, and one new applicant, Ryann Brooks, all have requested appointment to the new Council Advisory Commission. A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; APPOINTING SOPHIA ROSA, RYANN BROOKS, RYLEY ABSALON, AND AUBREY TRAVIS TO THE SIERRA VISTA YOUTH COMMISSION, SAID TERMS TO EXPIRE APRIL 30, 2025; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the Mayor and City Council have reestablished a Youth Commission to advise on matters of concern to the youth of Sierra Vista, and to recommend and encourage action programs and legislation beneficial to the youth of the community; promote better understanding and integration of youth and the local government, and assist in the planning, operation, and evaluation of the local service delivery system for youth related services as consumers of these services; and

WHEREAS, four applications have been received to fill five vacancies, and it is in the best interest of the citizens to have a full complement of Youth Commission members to address the concerns of the youth.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the City Council policy on term expirations and appointments to boards and commissions when qualified applicants are available is hereby reaffirmed.

SECTION 2

The City Council hereby appoints Sophia Rosa, Ryann Brooks, Ryley Absalon, and Aubrey Travis to the Sierra Vista Youth Commission, said terms to expire April 30, 2025.

SECTION 3

The City Manager, City Clerk, and City Attorney, or their duly authorized officers and agents, are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this resolution.

My name is Cadet 1SG Sophia Rosa and this email is to express my interest with becoming a member of the 2022 Sierra Vista City Youth Commission.

As a high school Junior, student athlete in Softball, and JROTC Cadet 1SG at Buena High School, I have participated in many

programs that have not only supported my academic and career goals, but provided me with the unique opportunity to develop myself as an JROTC leader, excel in the physical fitness activities, and perform various community service events with various Veteran and non-profit organizations that support the Sierra Vista's community members.

From academic school years of 2020-2022, I have excelled academically by taking Honors and AP courses at Buena H.S. while also being enrolled in ASU Prep Digital School to take courses concurrently and during the summer in order to advance my learning in other subjects. Despite having a rigorous academic schedule and maintaining a G.P.A. over 3.5 weighted, I'm also a part time employee at Culver's in Sierra Vista. Also prior to the start of the Buena Softball Schedule, I was on a 16U Competitive Softball Team in Tucson, Arizona where we competed throughout the state of Arizona and Texas.

Since the COVID 19 pandemic, many students like myself experienced several obstacles that affected our physical and mental wellness due to the restrictions and fear of the pandemic. In the summer of 2021, I was confronted those obstacles in the extreme way by attending and graduating from XMC Cadet a 2-Week Extreme Basic and Leadership Training Military Camp in Alabama.

This military leadership and training program taught me many values in personal courage, perseverance, drill and ceremony, water survival, leadership, team work, combatives, marksmanship, and physical fitness. Moreover, I was the only female of color to place in the top 4 in marksmanship.

In addition, I have accomplished and participated in school and community service activities such as performing my Color Guard Duties as an JROTC Cadet with the opening ceremonies at NASCAR in Phoenix, participating in the Color Guard during the Buena H.S. Football and Volleyball games, and helping various community service organizations with fundraising by helping with car washes. Also in 2020 I spearheaded a Strike Out Hunger Food and Turkey Drive with the Salvation Army by soliciting my previous 14U Travel Softball team to collect Turkeys and can goods for the Salvation during the Thanksgiving season. This food drive resulted in over \$1,000 to be donated from Safeway and over 10 Turkeys and several boxes of non-perishable items to be donated in 1 day. In addition, during the 2021 Presidential Campaign I completed 8 Volunteer hours to support Get out the Vote campaign by working the Voting Phone Banks up until the week of the local and Federal elections.

Moreover it was my distinct honor to be nominated, selected, and attended the National Youth Leadership Forum – Law & CSI Conference in Washington D.C. July 10, 2022. During this Youth Leadership Forum I immersed myself in learning about American Judicial Process, career exploration workshops, mock trial simulation, and toured colleges and Federal buildings. This academic school year, I plan on attending the National Youth Leadership Forum - Intensive Trial Law 10 day program session at Stanford University.

Also, currently another community activity I'm involved with is as a Student Intern with the SV Democratic Office to learn about the American Democratic Process. As a Student Intern I attend various campaign events and was a guest speaker twice to talk about problems youths have today. This Internship is scheduled to end November 2022.

I'm a strong advocate for Teen Mental Health specifically bringing awareness to Teen Mental Health among the Males with the goal to remove the stigma for this group to understand that everyone has stress and struggles with being a teenager. In addition, I believe that diversity of ideas and equal representative is important for communities to grow. Also, I would like to explore the opportunity for the Commission to have an Young Entrepreneur's Program where the program would have Business Mentors for Teens seeking to open their own small business. The Youth Commission could even have a Youth

Wellness and Business Expo in Mall with Youth Vendors to promote their products and services and receive wellness information! Finally, I feel that my leadership experience and passion to serve my community could contribute to goals and mission of the Youth Commission.

Finally, I look forward to discussing further on how we, the Youths of Sierra Vista, can support and bring meaningful resources and events to the youths in SV.

XMC is designed for teens interested in a possible military career, we are not a correctional camp. The young men and women that attend our programs have a history of doing very well within the military with many having been accepted to a U.S. Service Academy or to ROTC programs across the country.

While at XMC Sophia Rosa worked with service members from every branch of the U.S. military most notably our Drill Instructors which include USMC DIs, US Army Drill Sergeants and US Air Force MTIs. Our programs cover a wide range of topics but focus on basic military knowledge and bearing along with high-adventure training. Cadet Rosa completed the following tasks; obstacle course, marksmanship training, combat water survival, pugil stick training, level 1 Army Combatives, military inspections, rappelling, academic test, physical fitness test and critical thinking exercises. Cadet Rosa has participated in training on-par with (and in many cases surpassing) college ROTC activities and excelled.

Many young men and women attend our courses but only a fraction really push themselves the way Sophia Rosa has and as such she had leadership positions during her course. Our Basic Cadet Training 2-weeks is very realistic in nature with constant corrections by the DIs and a focus on motivation and attention to detail, it is a stressful program and can test the mettle of even the most dedicated young person. Cadet Rosa showed amazing fortitude and strength to complete these courses and exhibited the leadership traits that we were hoping for.

Sophia Rosa is a young woman full of potential. It is my opinion that Cadet Rosa has truly absorbed the purpose of our programs and is motivated for her future and that she is ready to show the world what she has to offer.
