RESOLUTION 2023-034, Tennis Courts Dedication

RECOMMENDATION:

The Director of Parks, Recreation, & Library recommends approval.

BACKGROUND:

The Parks and Recreation Commission is seeking approval from the Mayor and Council to dedicate the tennis courts located at the Veterans Memorial Park Sports Complex to Mr. Steven Bokowski. Mr. Bokowski was a long-time resident and tennis instructor at the former Kings Court Tennis Club. The Commission would like to host an official public dedication during the grand opening of the Veterans Memorial Park Sports Complex tentatively scheduled for June 2023.

Mr. Steven Bokowski taught tennis in Sierra Vista for 40 years. He grew up in Tucson and attended and played for Pima Community College. In 1981 he moved to Sierra Vista with his family to be a tennis instructor at Kings Court Tennis Club. In 1983 Steve was hired with the City of Sierra Vista to teach youth and adult tennis lessons as well.

During his 40 years in Sierra Vista, Mr. Bokowski taught and coached tennis to more than 7,000 kids and adults. He taught private and group lessons at both the Kings Court Tennis Club and the City of Sierra Vista courts (which are now the pickle ball courts located on Tacoma Street). Additionally, his summer programs through the City of Sierra Vista, which averaged approximately 100 participants each year, were a huge hit. You could always find kids on the courts smashing water balloons as one of his signature coaching activities.

Mr. Bokowski could always be found using his love for tennis to benefit the community. For years, Steve ran multiple tournaments, one of which was called the Forgach Open, a charity tournament that benefited the local crisis shelter. Coach Steve, as he was known, sent numerous kids, to include his son Brian and daughter Danielle, to college on tennis scholarships; approximately five former students went on to play professionally. To this day, Coach Steve still has students playing tennis in middle school and high school.

To honor his dedication to the youth of Sierra Vista, it is recommended that the tennis courts at
the Veterans Memorial Park Sports Complex be named The Steven Bokowski Tennis Courts.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA AS FOLLOWS:
