[Item 1](#) Acceptance of the Agenda

Council Member Landry moved that the agenda for the Regular City Council Meeting of May 4, 2023, be approved. Council Member Benning seconded the motion. The motion unanimously carried, 7/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

Presentations and Awards

Ms. Alexandra Kosmider stated that the Waterwise Youth Program with the University of Arizona has been doing the poster contest for many years, and they are happy to celebrate the hard work of the students and the teachers who helped promote the students' artistic abilities. The Waterwise Youth Program is dedicated to creating a culture of conservation in Cochise County. They go to classrooms, libraries, and after school programs throughout the County to teach about water and water conservation. The Mayor and Council presented a Proclamation declaring the Month of April as Water Awareness Month to Alexandra Kosmider, Instructional Specialist, Senior, Water Wise Youth, Cochise County Office, the University of Arizona. Ms. Kosmider thanked the Mayor and Council and stated that in addition to the Waterwise Youth Program, they also have a Waterwise Community Program which offers services in terms of education and helping people learn more about how they can save water in their own home and in their businesses. They offer mini grants for eligible businesses who are interested in lowering their water use. She further stated that anyone wanting to learn more about the program can visit their website: [waterwise.arizona.edu](http://waterwise.arizona.edu). Lastly, she thanked everyone for attending the meeting to celebrate the student artists.

The Mayor, Council, and Fire Chief Jones presented a Certificate of Appreciation to Patrick Jones for his support and dedication to the City of Sierra Vista Fire Department and surrounding communities.

Mayor McCaa stated that he has known Mr. Patrick Jones since high school and he remembers that while he was playing football, Patrick was always their cheerleader, had a positive attitude, and motivated the team to win. Throughout the years, he has seen Patrick around his brother, Fire Chief Jones, at the Fire Department. Therefore, he and Council are presenting him with a Certificate of Appreciation for his support and dedication to the City of Sierra Vista Fire Department and surrounding communities. Fire Chief Jones shared that growing up, Pat has been his inspiration because he lives life to the fullest daily, and everyone can all take that to do things. He also stated that Pat is involved in the Kiwanis Club, sings on two choirs, is with the Special Olympics, and does the torch run, although he rode in the Bearcat this year; but most importantly, back in 1995, he was invited to the World Track and Field Special Olympics Championship, which was in Connecticut, and he still holds the world record for the 400-meter race walk.



Mayor and Council presented a Proclamation declaring the Month of May as Mental Health Month to Deanna Bellinger, Emma Melo, and Lori Schectman. Ms. Deanna Bellinger stated that they are pleased to be celebrating 20 years since they incorporated and announced their upcoming march for mental health to commemorate National Mental Health Month in May. She further stated that anyone that might be interested in participating and forming a team or just signing up to walk and support their NAMI affiliate is welcomed. They provide support groups, mental health education, advocacy, help people with resources, and navigating the systems of care. They also have a mental health library with close to 2,000 mental health resources, and all services are free to the community.

Lori Schectman stated that most of mental health will be in the University Arizona South Gardens; therefore, walking around the gardens will be pretty.

City Manager's Report: Mr. Potucek announced that the next work session is on Tuesday, May 9, 2023, at 3:00 p.m. in the Council Chambers to discuss the balanced budget, SEACOM budget; reminded everyone that the regular Council meeting for May 11, 2023 will be cancelled, and on May 23, 2023, 3:00 p.m. will be another City Council work session focusing on the budget. The next regularly scheduled meeting is on May 25, 2023 at 5:00 p.m. in the Council Chambers as well. He reported that a pre-bid meeting and site visit was held April 27, 2023 for the Garden Canyon Linear Park Phase II ADA Paths at St. Andrews, with bids being due May 17, 2023; the sewer line and manhole repair bids are due on May 5, 2023; and staff has interviewed two firms, McGann & Associates and Wheat Design for the Roadrunner Park Design and expect to make an announcement of the award within the week. The annual street maintenance was awarded to KE&G, which is estimated for completion by June 30, 2023, that will result in \$1.2 million in repairs to the roads in the neighborhood off seventh north of Golf Links and Avenida Cochise east of BST. KE&G has begun work on the site prep for prefabricated bathrooms, which have been ordered, at Arbenz and Veterans Park, and the project is estimated to be completed at the end of June 2023. He reported that the SEACOM budget work session with the Board of Supervisors went well and the numbers which Council will see next week are close to the City's contributions for this current fiscal year. He also reported that he chaired the Refuse Rate Review Board and Tourism meetings and is pleased to report that the tipping fees will be kept at the same level that they are currently at. The tourism budget will be the same as the last fiscal year as well.

Mr. Potucek reported the funds on the opioid settlement are starting to be distributed and there are several stipulations on how to use them. The County is currently in receipt of those funds, over a half million dollars. The City's portion of it is \$87,000 and the County is going to start out by asking the communities for input on what they think the needs are first and then will decide as to how to move forward, which will require a Council vote. Lastly, he reported that the City received notification from a Border Patrol agent in charge regarding potential ramifications or impacts that may be seen because of Title 42 expiring on May 11, 2023. Therefore, staff is working very closely with congressional staff, Governor's office and County Emergency Management and trying to prepare for those potential impacts if they do occur. Staff is hoping to head them off first, but if not, the City needs to be prepared with a backup plan.

Council Member Johnson asked if there has been any thought about having the National Guard come out to the City. Mr Potucek stated that not yet because staff just found out about this, but the suggestion is not a bad idea.



Mayor Pro Tem Umphrey stated that she is aware that staff will be looking into the possibility of more Stone Garden funding because that is going to be an appropriation based off the call that from Senator Sinema.

Mayor Pro Tem Umphrey asked for the list of streets, once it is available, to be sent to Marcon to update the website because the current one is outdated.

Council Member Benning seconded the motion. The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

Council Member Benning thanked everyone that stepped up to serve the community and noted that it is a great decision that Council made on making them commissions again instead of what they were.

Council Member Rodriguez echoed Council Member Benning's sentiment and encouraged the people who showed up to go on YouTube and share with their friends the moment where their names were mentioned. He voiced his excitement at seeing the Youth Commissioners being present, a Commission that is near and dear to him. He thanked them for assisting the meeting, added that he looks forward to all the products that they are going to do, and apologized for the pause in their activities, but there were legalities involved - had to get the commissioners appointed. However, they are going to be back in full steam as soon as the Mayor hits the gavel. Lastly, he thanked all the commissioners who attended the meeting, for serving on a commission, and the community.

Mayor Pro Tem Umphrey echoed Council Member Benning and Rodriguez's statement. The Council is grateful for the willingness to serve. She then asked the commissioners to stay after the meeting so that they can be sworn in by the City Clerk.

Mayor McCaa thanked everyone for putting in the work, thanked his mother, Ms. McCaa, and added that he is looking forward to seeing wonderful things out of commissions, especially the Youth Commission with Council Member Rodriguez at the helm.

#### Public Hearings

[Item 3](#) Discussion and Possible Action of Resolution 2023-028, new license, Series 12 Liquor License for Fernando Mora Perez on behalf of the Takomaki Restaurant, 1481 E Fry Boulevard, Sierra Vista, Arizona

Council Member Rodriguez moved that Resolution 2023-028, new license, Series 12 Liquor License for Fernando Mora Perez on behalf of the Takomaki Restaurant, 1481 E Fry Boulevard, Sierra Vista, Arizona, be approved. Mayor Pro Tem Umphrey seconded the motion.

Ms. Adams stated that this is a restaurant liquor license for the Taco Maki Restaurant located at 1481 E Fry Boulevard. The notice of the public hearing was posted on the facility the required twenty plus days, and no citizens have commented on the liquor license, pro or con. The Police Department has done a background check of the applicant and has no objection to moving forward. If approved, it will be forwarded to the State Liquor Board for final approval.

Council Member Rodriguez stated that he went by the shopping strip is, formerly known as Mi Yaki Tacos Raspados and noted that they have a lot of work to do. Mayor Pro Tem Umphrey added that it is going to be Mexican, Japanese food, and she want to go try it.



The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

Item 4 Consideration of DRAFT PY 2023 Community Development Block Grant (CDBG) Program Annual Action Plan

Mr. McLachlan stated that the Annual Action Plan is the City's funding application to HUD for Community Development Block Grant funding. It follows a federally prescribed format, responds to a series of questions that the City must address. There is some boiler plate information that gets carried over year to year and updated so some of it may look familiar. The most important part of the Plan is the proposed use of next year's funding. The City is expected to receive just over a quarter \$1,000,000. The allocations in the Plan reflect the direction of the Council following the applicants' presentations in March. The bulk of the funds will be spent on installing 10 to 12 strategically placed fire hydrants in the Montebello Subdivision. This is one of the areas that was identified for CDBG investment due to its low to moderate income status. The maximum amount available for program services is being divided up amongst the three nonprofits that made application, United Way of Sierra Vista, Cochise County, and the Cochise Family Advocacy Center, which are each proposed to receive \$15,750. The amount of \$6,000 will be going to Southern Arizona Legal Aid for services, benefiting low to moderate income clientele. The draft Plan also sets aside \$50,000 for the update of the City's Five-Year CDBG Consolidated Plan, which is due next year, as well as other regulatory compliance measures. In terms of next steps, staff will be providing any additional feedback received during the public comment period that closes on May 14, 2023. During the Council's May 25, 2023 meeting, staff will be requesting final approval of the Plan. Staff will then submit it to HUD, 45 days to review and approve. The City expects the grant agreement late summer, early fall.

In response to Council Member Rodriguez, Mr. McLachlan stated that the Montebello Neighborhood is southwest of the Charleston Road, Julio Cesar intersection. It was annexed about 13 years ago and has 250 lots with no hydrants. The City will be curing that deficiency through this grant.

New Business

Item 5 Discussion and Possible Action of Resolution 2023-029, Amendment to the City Board and Commission Guidelines

Council Member Benning moved that Resolution 2023-029, amendment to the City Board and Commission Guidelines, be approved. Council Member Johnson seconded the motion.

Ms. Adams stated that a couple of meetings ago, Council made their commissions Council advisory bodies. Council appointed members for the commissions, and this item provides those commissioners with guidance as to operating policies, open meeting law, and diverse types of things to help them better perform the duties of City Council Advisory Commissioners. The most recent changes were updated from a couple of years ago when the commission structure changed that has now reverted to Council Advisory bodies. The major change is the description of the new commissions. Staff will continue to update the guidelines because this is a living document, at least every couple of years to make sure that it is current and reflects the practices of the commissions. Lastly, she stated that now that Council has appointed some commissioners, commissions will be able to meet and set meeting schedules that will be put on the City website to get the word out and hopefully get some more interested bodies to fill some of the vacancies.



Mayor McCaa stated that he wants to make sure that the commissioners read the Open Meeting Law. Ms. Adams stated that all these documents will be emailed to all the commissioners as soon as they are signed and inked.

The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

Item 6 Discussion and Possible Action of Resolution 2023-030, Amendment to the City Council Policy and Procedure Guidelines

Mayor Pro Tem Umphrey moved that Resolution 2023-030, amendment to the City Council Policy and Procedure Guidelines, be approved. Council Member Benning seconded the motion.

Ms. Adams stated that as discussed during the Council's Retreat in January, Council Member Johnson had requested updates to the City Council Travel Report Policies, which is the major change in the document. The document now requires that Council Members who travel on City expense accounts come back and provide a report of what they gathered from their travels and conferences, which will be made public after they submit them. There were also some minor formatting changes and bringing things up to the current terminology.

The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

Item 7 Discussion and Possible Action of Resolution 2023-031, Intergovernmental Agreement between the City of Sierra Vista, the Cochise County Sheriff's Office, and the Cochise County Community College District

Council Member Johnson moved that Resolution 2023-031, an Intergovernmental Agreement between the City of Sierra Vista, the Cochise County Sheriff's Office, and the Cochise County Community College District, be approved. Mayor Pro Tem Umphrey seconded the motion.

Police Chief Thrasher stated that this resolution amounts to a continuation of previous agreements with Cochise College and the Cochise County Sheriff's Office to operate the Southeastern Arizona Law Enforcement Training Academy on the college campus. This renews for two more classes for the next year. The agreement is the same as previous agreements, except that this one specifies that the Academy will be moving to the Sierra Vista campus in January of 2024.

Mayor Pro Tem Umphrey stated that Council was presented with updated numbers of graduates at the Mac Luncheon. She noted that it is great to see how many of the most recent recruits have come out of that Academy because it feels like just recently the City switched over from Tucson. She added that it is not just the City that is benefiting. It looks like most recruits are benefiting the Sheriff's Department. Police Chief Thrasher added that it is the Sheriff's Department and reservations. Currently the City has four in this current class, which will graduate on May 25, 2023.

The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.



[Item 8](#) Discussion and Possible Action of Resolution 2023-032, Acceptance of the Arizona Department of Homeland Security Grant Funding-Operation Stonegarden Grant Program (Agreement #220425-01)

Council Member Johnson moved that Resolution 2023-032, acceptance of the Arizona Department of Homeland Security Grant Funding-Operation Stonegarden Grant Program (Agreement #220425-01), be approved. Council Member Benning seconded the motion.

Police Chief Thrasher stated that this resolution authorizes the City to accept a grant from the Arizona Department of Homeland Security regarding Operation Stone Garden Grant Program. These funds are used to pay overtime and mileage for service to police department officers to act as a force multiplier with Homeland Security for border security and overall security in the area. The amount of this grant is \$172,640 for overtime and employee related expenses and another \$10,000 for mileage for vehicle maintenance. This grant requires no match, is reimbursable, and it covers the overtime, employee related expenses including PSPRS liability.

The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

[Item 9](#) Discussion and Possible Action of Resolution 2023-033, Intergovernmental Support Agreement with Fort Huachuca to provide Fire Suppression Systems Inspection, Maintenance and Repair Services Provided by a Third-Party Contractor

Council Member Rodriguez moved that Resolution 2023-033, an Intergovernmental Support Agreement with Fort Huachuca to provide Fire Suppression Systems Inspection, Maintenance and Repair Services Provided by a Third-Party Contractor, be approved. Mayor Pro Tem Umphrey seconded the motion.

Ms. Downing stated that Fort Huachuca has approached the City and inquired about entering into an intergovernmental support agreement for mutual city services that the does and that they need. In anticipation of having an IGSA, they are looking to partner with the City to see if they can save money for fire suppression systems, inspection, maintenance, and repair services. The City currently has a two-year contract with a company in Hereford, Showtime Fire Protection. Fort Huachuca would be piggybacking off the City's contract and taking advantage of the prices. When that two-year contract expires, the City would rebid it, adding the City's quantities and Fort Huachuca's quantities together in hopes of reaping even a better savings because now it will be a higher volume. The benefit to the City is that the City would get lower prices because the volume of work is higher. Fort Huachuca also saves money because federal contracts have a lot of requirements. This IGSA would have the City as the project manager, and the City would be doing the purchase order to Showtime on behalf of Fort Huachuca. Showtime would be billing the City of Sierra Vista, and the City would pay the bill to Show Time and would in effect bill Fort Huachuca for services, and this is how the IGSA relationship is created.

The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

[Item 10](#) Discussion and Possible Action of Resolution 2023-034, Dedication of the tennis courts located at the Veterans' Memorial Park Sports Complex to Steven Bokowski



Council Member Benning moved that Resolution 2023-034, dedication of the tennis courts located at the Veterans' Memorial Park Sports Complex to Steven Bokowski, be approved. Council Member Johnson seconded the motion.

Ms. Wilson stated that the item before Council is a request to dedicate the tennis courts located at the Veterans Memorial Sports Complex to longtime resident and tennis coach Mr. Steven Bokowski. Mr. Bokowski grew up in Tucson and played tennis for Pima Community College. He moved here to Sierra Vista with his family in 1981 and taught tennis lessons for adults and children at the former Kings Court Tennis Club and for the City of Sierra Vista for 40 years. During his time, Coach Steve worked with over 7,000 area tennis players. During his summer sessions, one could always find his younger students on the courts smashing water balloons with tennis rackets as a fun coaching activity designed to keep kids cool while falling in love with the game. Coach Steve was also charitable and used his love for the game of tennis to support local charities. He ran several local tournaments and utilized the funds for scholarships for students and to benefit a local crisis shelter. Many of Steve's students went on to do amazing things. Several played in college to include his own son Brian and his daughter Danielle, and five of his students went on to play professionally. Others are still playing in middle school and high school today. Steve passed away on June 16th, 2021, but the impact he made is still felt through his family and the influence he had on those that he taught. For these reasons, the Parks and Recreation Commission unanimously recommend that the newly renovated tennis courts located at the Veterans Memorial Park Sports Complex be dedicated as the Steven Bukowski tennis courts.

Council Member Landry stated that Coach Steve was a great person. She shared that her son was fortunate to take some classes with him during the summer a few years back and noted that he still remembers Coach Steve and the wonderful time that he had. It was great to watch Coach Steve interact with the kids in getting them so enthused. Coach Steve was passionate about what he did, and she appreciates that the City is naming the Sports Complex after him.

Council Member Benning stated that the Park and Recreation Commission approved this action, 5/0, and they bring this type of stuff to Council, and help. He noted that he could not be prouder of his Park and Recreation Commission, a good dedication.

The motion unanimously carried, 6/0. Mayor McCaa, Mayor Pro Tem Umphrey, Council Members Benning, Johnson, Landry, Rodriguez, and Messmer voted in favor.

#### Call to the Public

Berlynda Schaaf, a member of the Park and Recreation Commission and the District 8 Treasurer for Little League in Sierra Vista explained that there are seven or eight leads, Bisbee, Douglas, Sierra Vista that has the League and Ponytail, Benson, Wilcox, Nogales, and Rio Rico. She announced that Sierra Vista Little League will be hosting the State Baseball Tournament, 9, 10, and 11 years old. The date has not yet been determined, but it will be in the July time. The tournament will be held at the Stone Complex fields and there will be over fourteen teams traveling to Sierra Vista to play; therefore, they are hosting for the entire State of Arizona. She noted that Police Chief Thrasher comes out to help along with his wife Jen. They all they get subjected to books and he is deeply knowledgeable of the rules and usually 99 percent of the parents do not argue when he is there. She thanked Ms. Wilson for coming out and throwing the first pitch for them during opening ceremonies, and Mayor McCaw for coming out and seeing the big turnout for the opening ceremonies. The Avengers Division, special needs kids, attended the opening ceremonies. They range from age five to 19 years old. The teams are split so that



they can play real baseball. The Littles play Saturday mornings at 8:30 a.m. and the Bigs play at 6:00 p.m. on Saturday night. They do not just do baseball because as soon as baseball ends, they are bowling, and from bowling they go to soccer, and then from soccer, they go into basketball, which was recently added. There is continuous work with the kids. Lastly, she announced that they will be hosting district tournaments for senior baseball and 9-, 10-, and 11-year-olds baseball, which will be held in June at Stone Complex on Arbenz Field.

#### Comments and Requests of the Council

Council Member Benning thanked Ms. Schaaf for everything she does, Jessica Kunkle, and Mr. Hayes, who are incredibly involved with the youth and sports programs. He noted that without people like that, the sports tourism would not begin to take off. He congratulated Mr. Jones on his certificate of appreciation, well deserved, and thanked him for his recommendation to Mr. Potucek on Fire Chief Jones. He also thanked Officer Scott, who rides the Police Department motorcycle for pushing a truck that had broken down out of the street. He does this all the time as well as the EMTs and firefighters. Lastly, he stated that May 4, 2023 is National Prayer Day, and it was made even better by the Interdenominational Christian Ministries. This is the 75th year that the president has made a proclamation declaring May 4<sup>th</sup> as National Prayer Day. Sometimes people do not speak up, and they may not have the same God, they may not believe, but he has the armor of God around him, and he believes that this is the way to go, where one needs to go with their lives. He was able to break bread with a lot of his fellow Council Members, the Mayor, and great leaders of the City of Sierra Vista. He was also able to talk about what they can do going forward, how to get better at what they are doing and forget some of the worries, pray for the nation, pray for the country, and most importantly, pray for Sierra Vista.

Council Member Landry congratulated the youth poster winners, noted that there was a lot of participation, and that it was great to see their art. She stated that there is a lot of talented youth in the community and thanked them for participating. She thanked the Mayor and Council for declaring May as Mental Health Month and stressed the important of breaking the stigma around that, encouraged people to check out the march for Mental Health with NAMI and their October Sky Island bike ride. She further stated that it is the end of the school year and being a teacher is a thankless job, but it has such a positive ripple effect on the community, on the world. She encouraged people to thank a teacher, show them some extra love because it has been a tough year and it is a tough job. She wished everyone to finish the school year strong and to have a good summer. Although, some will be in summer school. She also encouraged people to reach out to any of the Mamas that they know whether it is your own, your favorite one, any new moms, anybody that might be having a Mother's Day different from in the past and show them some love as well. Lastly, she announced that the Animal Shelter is currently in need of bleach, and donations are appreciated. She then thanked all the new Commission Members for serving.

Council Member Johnson congratulated the Water Wise Poster winners and stated that he was amazed at the good artists in the City's schools. He also congratulated the commissioners and thanked them for serving. It is a commitment and Council appreciates their input. Lastly, he congratulated Mr. Jones on his recognition and shared that he is always singing in the church choir.

Council Member Messmer congratulated everybody and Mr. Jones on his award. She announced that the Historical Society is having their fundraiser on May 5, 2023 and there are still tickets available through their Facebook page or Instagram page, Neighbor page. She also



announced that the museum will open on Saturday, May 6, 2023 with their Jurassic Wonders from 1:50 p.m., starting with their grand opening ribbon cutting.


Council Member Rodriguez reported on the Special Olympics Run, gave a shout out to Todd from Cool FM, who was out their running with the camera the whole time, the Police Department, Officer Grady, and the State Troopers. He also reported on Fort Huachuca's Spring Career Fair and noted that it was good to see that the City had a table out there because soldiers getting out of the military may want to stay in the area because the City has a lot to offer. He announced that May 4, 2023 is International Firefighters Day and noted that there are a lot of firefighters in the area, Palominas, Bisbee, Sierra Vista Fry, Fort Huachuca, Whetstone, Forestry, Hotshots, and gave a shout out to them in attacking fires every day. He also gave a shout out to Youth Commissioner Sofia Rosa, who is going to ASU, and who competed and won a grant through Travis Leadership Institute. He also announced that it is Municipal Clerks week, and thanked Ms. Adams, an awesome person, who keeps Council out of trouble. He encouraged people to go to the Festival of the Southwest during the weekend at Veterans Memorial Park, announced that the Legacy Foundation had their open house during the week celebrating 10 years, and noted that they do wonderful things for the community, a lot of grants that are made possible by them. He added that they are building an event center on the back. In closing, he announced that there is Fort Huachuca poker run on Friday, May 5, 2023 and cautioned people to keep an eye out for motorcycles. Lastly, he stated that the City also said goodbye to the Sister City students, which seemed to want to stay. He then mentioned that with all the sports going on, there are kids as well, but people are still speeding. People are not paying attention to the speed limit and the Police Department can only be so many places at one time; therefore, he asked that people slow down.

Mayor Pro Tem Umphrey had nothing to report.

Mayor McCaa congratulated Mr. Jones and voiced his appreciation at his motivation and enthusiasm. He shared that his last etched memory of him is from 1983 when they were going to Mountain View to play the regional football game and he was out there cheering them on, but they lost 35 to 3. He congratulated all the commissioners and noted that he is looking forward to their comments. He announced that on May 1, 2023, Council signed the Strategic Plan with USAICoE, NETCOM, the Intel Center and network communication with General Hale and General Review Base and noted that Sierra Vista is privileged to be a part of that process going forward with the Strategic Plan. He also announced that last week he testified before the Senate Subcommittee on the Government Operations and Border management of the US Senate Committee on Homeland Security and Government Affairs to examine the effects of increased migration on the on the communities that are along the border. He thanked Ms. Yarbrough and Police Chief Thrasher for their input. In closing, he thanked God for these great leaders, Council, people that are doing an amazing job going forward in leading the City into a higher dimension. Lastly, he announced that Tuesday, May 2, 2023 was Principals Day and gave a shout out to Ms. Nicole Young.
