A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; REAFFIRMING VISTA 2030, THE CITY OF SIERRA VISTA GENERAL DEVELOPMENT PLAN, ACCEPTING SEWER LINE EASEMENTS FOR VERITAS CHRISTIAN COMMUNITY SCHOOL.; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, Veritas Christian Community School desires to install a sewer line on properties as identified in Exhibit A; and

WHEREAS, the property owners identified on the deeds wish to dedicate sewer easements to the City for the sewer line extension; and

WHEREAS, the sewer easements are in conformance with Development Code requirements; and

WHEREAS, the City desires to accept the easements offered by the property owners identified on the deeds; and

WHEREAS, it is settled policy of the City Council that dedication is considered as satisfactorily assured when documents granting the required easements have been accepted for recordation by the City Council pursuant to the City of Sierra Vista Development Code.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:






