Therefore, City staff recommends that Victoria Yarbrough, Assistant City Manager, be appointed to serve out Ms. Fleming's remaining time on both boards with said terms to expire August 1, 2024.

The Mayor and City Council hereby accept the resignation of Barbara Fleming from the Sierra Vista Police and Fire Pension Boards and appoint Victoria Yarbrough to finish said terms set to expire August 1, 2024.
